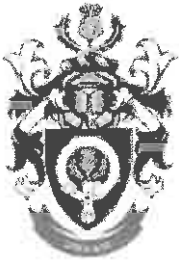

 - copies of Passport / Asylum seekers permit / Refugee status for non – South African citizens
 - Certified copies of a valid Study Permit
 - Certified copies of proof of residence of both parents (*if different*)
If not living in feeder area, check for proof of employer address.
- A letter of employment for each parent/legal guardian confirming employment, on an original company letterhead and must be stamped and signed by the Employer
 - Certified copies of guardianship (**valid court order**) if not the biological parents of the learner

RE: APPLICATIONS FOR 2022

Kindly note that all immigrant parents and/or parents of immigrant learners with study permits and/or temporary residence permits, are obliged to pay the full school fees in advance as decided at the Annual General Meeting of Parents, which was held on 20th October 2020. That means that total school fees are payable before the learner starts.

Please see that all the relevant documentation i.e. Study permits or proof of receipt of application at the Department of Home Affairs etc. are in order.

The application to the school will lapse: -

- a) if the parent fails within two weeks of submitting the application to provide proof to the school that he/she has applied for a permit for temporary or permanent residence or a study permit with the Department of Home Affairs.
- b) if the necessary documentation is not submitted by the parent within six weeks of submitting the application (unless good cause is shown by the parent).
